



## SEATTLE WINDOW DEFOGGERS LLC TEN (10) YEAR WARRANTY

Seattle Window Defoggers LLC offers, subject to the conditions and restrictions contained below, a **TEN (10) YEAR WARRANTY** for both Commercial and Residential Services. The warranty period begins upon the date of original installation. **Seattle Window Defoggers** ten (10) Year warranty is fully transferable as long as the original receipt is produced for any warranty claims. All claims under this warranty must be made in writing to **Seattle Window Defoggers** within thirty (30) days of discovery of any damage or defect.

### LIMITED WARRANTY

**Seattle Window Defoggers (SWD)** offers a ten (10) year warranty against seal failure from the date of original installation as long as full payment was received, and includes full labor and IG unit costs. The Warranty, however, does not apply to any IG unit installed over 15 degrees from vertical. The Warranty is fully transferable for the Warranty Period as long as the original receipt is produced for warranty claims.

**Seattle Window Defoggers** shall not be liable in any way for damage or defect due to accident, mishandling, or improper use; negligent operation; improper maintenance; fire, flood, earthquake, storm, tornado, acts of nature; damage caused by chemicals, salt, acid rain, airborne pollutions or application of corrosive substances; use of the product for purposes other than those for which it was designed; unauthorized attachments, tints, films, repairs or modifications; mineral deposits, etching or pitting of window glass; water seepage due to lack of maintenance, faulty trim/frames, high pressure spraying or cleaning; condensation on external glass surfaces whether inside or outside the building; or any other abuse, misuse or other cause beyond the control of **SWD**. All disclaimers and exclusions contained herein apply under all conditions.

### OPTIONAL UPGRADE TO MANUFACTURER'S LIFETIME WARRANTY\*

Manufacturer's Warranty becomes applicable after **SWD's** Warranty expires or in the event **SWD** is no longer in business. Lifetime Warranty is not available for Commercial applications.

- Manufacturer's Warranty is exclusive of **SWD** and is a direct agreement between Manufacturer and Consumer.
- Manufacturer's Warranty is NOT transferable
- Labor costs are NOT covered under this warranty
- Proof of original purchase is required
